Requirements for particular types of measuring instruments.

The detailed scope of tests and checks to be carried out during the legal metrological control.

oscillatory-type density meters for measuring liquid density

Regulation of the Minister of the Economy of 19 April 2007 on requirements to be met by oscillatory instruments for measure liquid density and the detailed scope of examinations and checks to be carried out during legal metrological control of these measuring instruments. glass areometers

Regulation of the Minister of the Economy of 19 July 2007 on requirements to be met by glass areometers and the detailed scope of examinations and checks to be carried out during legal metrological control of these measuring instruments. (Journal of Laws No. 144, item 1007)

pressure gauges
